HART OF TEXAS FOSTER HOME AGREEMENT

This is a Foster Home Agreement between _____
and HART of Texas, P.O. Box 153293, Irving, Texas 75015-3293 and is applicable to any animal this
foster volunteer is asked to foster.

All animals are to be housed, fed and cared for by above-mentioned foster volunteer making no charges
of any character for licensing, care, food or service. The Foster Home Volunteer shall be personally
responsible for the humane care, treatment and control of animal(s) in his/her care until returned to
HART of Texas. The above Foster Home Volunteer shall not hold HART of Texas, its volunteers, staff or
Board of Directors responsible for any damages resulting from scratches, bites or material damage.
HART of Texas will retain ownership of all animals in foster care, and will make all decisions regarding
the adoption or euthanasia of the animals fostered.

_____I do understand that by participating in HART's foster program I may receive an animal that has an
undetected contagious medical condition. I understand that my personal pets may contract illnesses
passed on from the foster animal and will in no way hold HART liable for any conditions my personal pet
may contract. (HART recommends that you keep your personal animal(s) separated from the foster
animal for a minimum of 10 days as a precaution.)

_____I acknowledge that I have read, understand and will adhere to all the terms, conditions, policies
and procedures of HART of Texas Foster Home Program. I do understand that if at anytime, I cannot
fulfill these terms, conditions, policies and procedures of HART of Texas Foster Program I will; by mutual
agreement end my tenure as a Foster Home Volunteer.

_____I acknowledge the ordinances of the city in which I reside and will not exceed the amount of
animals I am authorized to house based on the city guidelines.

This foster agreement is made between that HART of Texas, whose purpose is to protect animals and the individual/s whose signature/s appears below. The foster parent agrees to all of the conditions set forth below.

1. All foster animals shall be provided with proper food, fresh water and proper shelter. All members of the foster household will treat the foster animals humanely.
2. The parent will not dispose of the animal in any way. The foster parent cannot give the animal away to another animal humane society or person, and will not abandon the animal in any way.
3. The foster parent agrees that in the event that he/she is unable or unwilling to continue the care for the animal, the animal will be promptly returned to HART of Texas.
4. The foster parent agrees that all dogs and cats in custody be spayed / neutered. If not currently spayed/neutered, the animal being fostered is either ill or too young to undergo a sterilization procedure. The foster parent agrees NOT to use this animal for any type of breeding purpose.
5. If a representative of HART of Texas determines that the foster parent is not caring for the animal/s properly, HART of Texas has the right to take possession of the animal/s and cancel this agreement. The foster parent agrees to allow HART of Texas to have access to his/her premises at reasonable hours to allow inspections. The foster parent also consents to allow HART of Texas to have access to his/her premises to take possession of the animal/s if HART of Texas deems this action appropriate, and further agrees that no court proceedings will be required to obtain possession of the animal. The foster parent understands the below referenced animal/s remain property of HART of Texas.
6. If the foster parent expresses an interest in adopting the animal being fostered, the foster parent agrees to complete the adoption application and return the animal for all necessary procedures. The foster parent understands that HART of Texas has the right to refuse any adoption for any reason.
7. The foster parent accepts any/all liability for any damage caused by this animal while it is under his/her care. A foster parent will not be reimbursed if he/she takes the foster animals to an animal clinic other than HART of Texas.
8. The foster parent agrees to return any equipment that is the property of HART of Texas and identified below as being borrowed by the foster parent for use in care of the animal/s being fostered.
